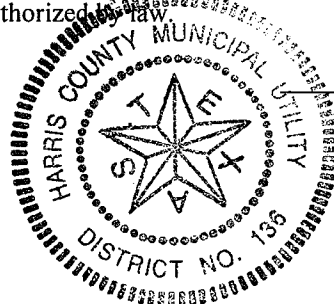
NOTICE
