

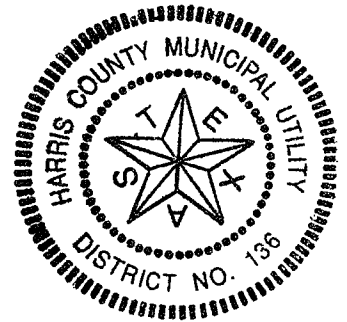


NOTICE
