



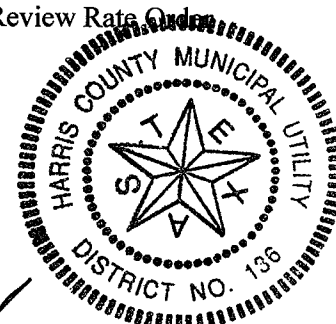
NOTICE
